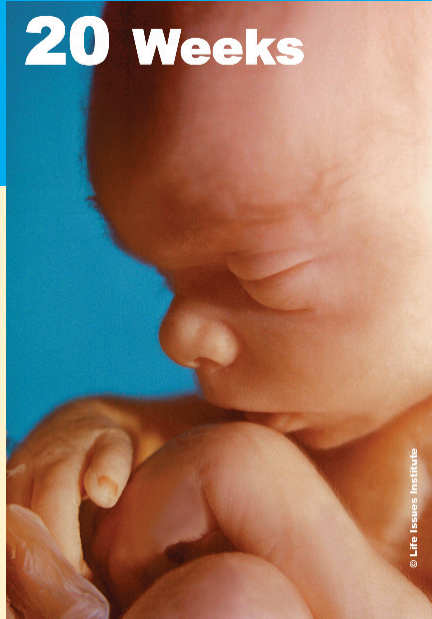

What a
beautiful choice

Is it wrong to kill little babies like this one?

Of course it is.

Yet each week over 35 babies – up to 20-weeks old – are killed in the most brutal ways imaginable at 1401 East Stroop Road in Kettering.

Can it be stopped?

Surprisingly, the answer is yes.

Even after over 40 years of legalized

abortion, there is a fairly straightforward way to stop it:

Make abortionists obey Ohio law that requires them to have a transfer agreement at a nearby hospital.

No local hospital will grant a transfer agreement to owner/abortionist Martin Haskell or to Roslyn Kade, who does most of the abortions in Kettering. And it's not just here in the Dayton area. They can't get a transfer agreement from any hospital in Cincinnati.

Unfortunately for the babies and mothers, the law has an escape hatch that allows abortionists to skirt the requirement — one that every other ambulatory surgical facility in the state is required to meet. Abortionists can get a waiver — *IF* — they can find doctors who do have a relationship with a local hospital and who will agree to provide emergency back up services.

Haskell now has such an agreement with members of the **Wright State Physicians** group. The group com-

prises doctors who teach at **Wright State's Boonshoft School of Medicine** and have admitting privileges and offices at **Miami Valley Hospital**. They also have offices at **Wright State Physicians Health Center** at Wright State University.

In the past, the state has ordered abortionist Haskell to shut down the Kettering abortion center for not providing proof of a transfer agreement.

In 2014, the Ohio Dept. of Health closed down his surgical abortion activities in Sharonville for not having a transfer agreement with a local hospital.

Even with his contract with the Wright State doctors, Haskell's latest request for a variance — which would allow him to stay in business in Kettering — has been denied by the Ohio Department of Health. Following a final ruling on the denial, the next step in the process is for the state to issue a shut-down order for the Kettering abortion center.

However given the appeals process and other court suits and decisions, it

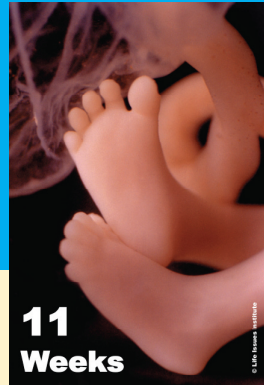
is likely that the abortion facility will remain open and that the agreement with the Wright State doctors will remain in effect.

Given that their support in the past has enabled the abortion facility to stay open and that their continued support could help it to stay open in the future, we're calling on members of the Wright State Physicians Group to withdraw from their agreement with the abortionist.

In addition, the doctors — as staff members of a tax-payer supported medical school — should not be using their positions to support activities like abortion, which violate the consciences of millions of Ohio citizens.

Abortion does not heal. It leaves a dead baby and can leave the mother with devastating medical and psychological problems.

And it's not necessary. Abortion does not treat a disease or injury. The vast majority of elective abortions involve a healthy mom and a healthy baby.

In those rare cases where the life of the mother is threatened, the patient belongs in a hospital with doctors who strive with all their skill to save *both* the mother and the baby. Our community offers a wonderful variety of positive alternatives that address every circumstance that might lead a mother to consider an elective abortion.

We urge the Wright State physicians to *help* women in crisis pregnancy situations — *not hurt them* — by enabling elective abortion to continue. Members of the Wright State Physicians Ob/Gyn group involved in providing emergency back up services for the abortion center include:

We also ask officials at Wright State University and at Miami Valley Hospital, as well as other doctors — or students — who may be

acquainted with the Wright State physicians to use whatever influence they have to urge members of the group to stop supporting Haskell's abortion business. We ask any patients of these doctors to discuss this issue with them and express their concerns.

We ask that concerned citizens contact officials at Wright State University, at the Wright State Physicians Group, at Miami Valley Hospital, and ask them to urge the doctors' group to withdraw their support for the abortionists.

Finally, we urge everyone to support the women's centers, adoption agencies, churches and other organizations who provide so many wonderful, loving, life-giving alternatives to elective abortion.
